

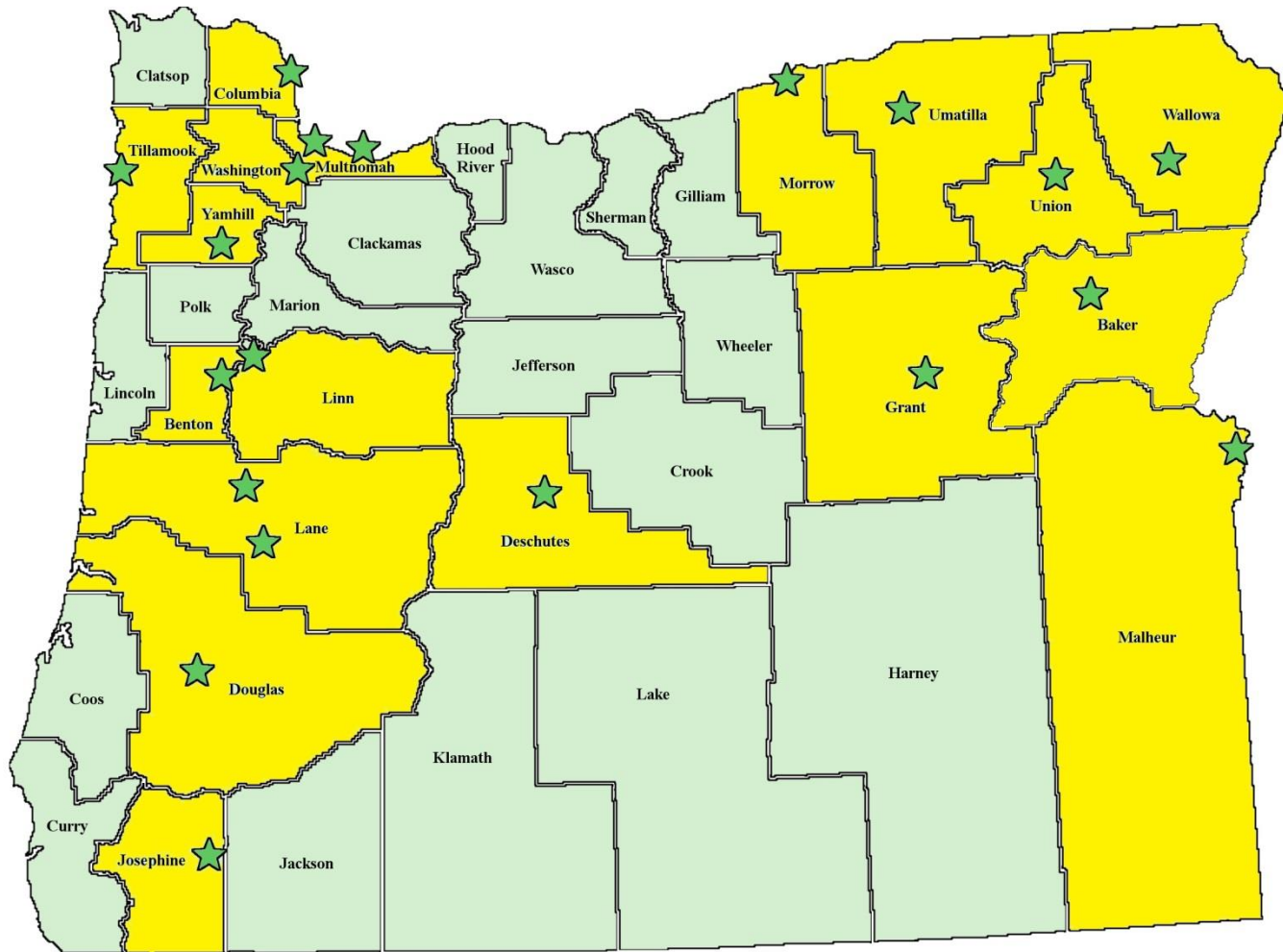
OCEACT was created July 1 2013
